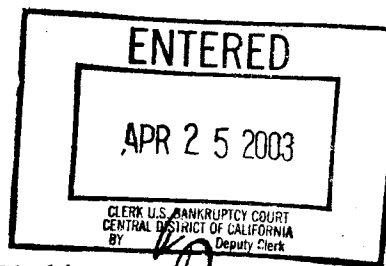
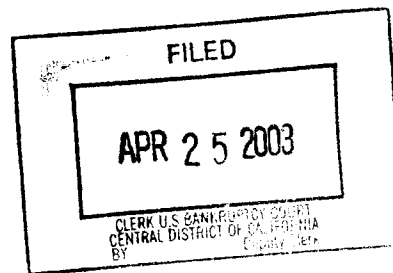

1 Having granted the Motion for Approval Of Stipulation For Entry Of Judgment  
2 Against Jeanne Lan (the "Motion") filed in In re Reed E. Slatkin, Case No. ND 01-11549-RR  
3 (the "Slatkin Case"), by R. Todd Neilson, trustee (the "Trustee") of the chapter 11 bankruptcy  
4 estate of Reed E. Slatkin; having entered in the Slatkin Case the Order On Trustee's Motion  
5 For Approval Of Stipulation For Entry of Judgment Against Jeanne Lan; defendant Jeanne  
6 Lan ("Ms. Lan") and plaintiff Trustee having entered into the Stipulation for Entry of  
7 Judgment Against Jeanne Lan (the "Stipulation"), and said Stipulation having been filed in  
8 this adversary proceeding; and good cause appearing, the Court hereby enters judgment by  
9 stipulation against Ms. Lan and in favor of the Trustee as follows:

10 **IT IS HEREBY ORDERED, ADJUDGED AND DECREED** that:

11 **I.** The Trustee shall have judgment against Ms. Lan in the principal sum of  
12 \$958,285.11 (the "Judgment Amount"), which includes and subsumes the following:

13 **A.** On the first claim for relief of the Complaint (to avoid intentionally  
14 fraudulent transfers of money and other property under 11 U.S.C. §§ 544(b) and 550(a)  
15 and Cal. Civ. Code §§ 3439.04(a) and 3439.07), the principal sum of \$958,285.11;

16 **B.** On the second claim for relief of the Complaint (to avoid intentionally  
17 fraudulent transfers of money and other property under 11 U.S.C. §§ 544(b) and  
18 550(a) and Cal. Civ. Code §§ 3439.04(a) and 3439.07), the principal sum of  
19 \$955,000.00;

20 **C.** On the third claim for relief of the Complaint (to avoid constructively  
21 fraudulent transfers of money and other property under 11 U.S.C. §§ 544(b) and  
22 550(a) and Cal. Civ. Code §§ 3439.04(b) or 3439.05 and Cal. Civ. Code §  
23 3439.07), the principal sum of \$955,000.00;

24 **D.** On the fourth claim for relief of the Complaint (to avoid and recover  
25 intentionally fraudulent transfers of money and other property under 11 U.S.C. §§  
26 548(a)(1)(A) and 550(a)), the principal sum of \$115,000.00; and

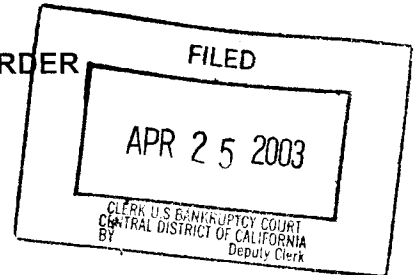
