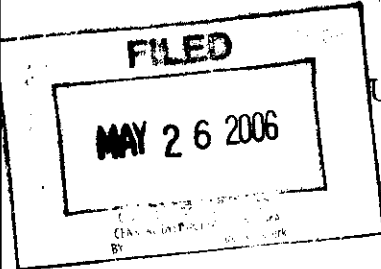
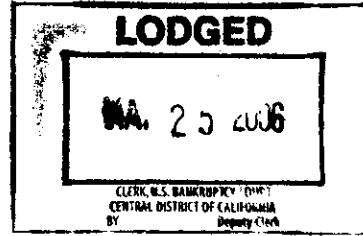


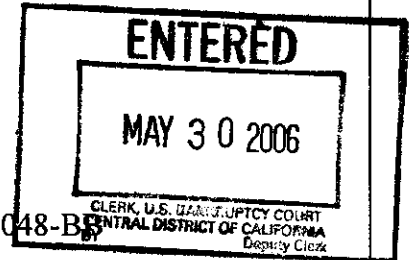

25 This stipulation is entered into among Plaintiff Rosendo Gonzalez, Chapter 7 Trustee
26 ("Plaintiff") of the bankruptcy estate of Roy McNeill ("McNeill" or the "Debtor"), on the one hand,
27 and Defendants Church of Scientology Flag Service Organization, Inc. ("FSO"), Church of
28 Scientology International ("CSI"), Church of Scientology Celebrity Centre International ("CCI") and

1 Church of Scientology Religious Trust ("CSRT", and together with FSO, CSI and CCI, the
2 "Defendants"), on the other, through their counsel of record, and is made with reference to the
3 following facts. Plaintiff and Defendants are collectively referred to herein as the "Parties."

4 1. Plaintiff and Defendants have reached a settlement of this adversary proceeding
5 embodied in a Settlement Agreement and Mutual Release (the "Settlement Agreement").

6 2. The Settlement Agreement was approved by the Court pursuant to that certain Order
7 Approving Compromise of Controversy entered on or about April 11, 2006.^{L.A.P.}

8 3. The Settlement Agreement has been consummated.

9 4. The Parties wish to dismiss the within adversary proceeding with prejudice, each
10 party to bear its own attorneys' fees and costs.


ORDER




