SUPPLEMENTAL REPORT

INCIDENT: **SEXUAL ASSAULT**

SUSPECT: **WILLIAMS, GABRIEL** ADDRESS:

If you say anything I will kill you

1 not get into trouble for what he did. The suspect said [REDACTED]
2 The victim said she was afraid of the suspect.
3 The victim slept on the couch in the living room and the suspect went to bed in his room. The
4 next morning on the way to the church the suspect said [REDACTED] *remember what I said.*
5 did not say anything about the incident to anyone.

6
7 The second incident occurred the next night after the suspect and the victim returned to the
8 suspect's house after working all day at the church. They returned home at approximately
9 2300 hours. The suspect and the victim were watching t.v. on the couch. The suspect
10 grabbed the victim's upper arms with a tight grip. He pulled down the victim's sweatpants.
11 The victim said, "It felt like a replay. Like the same thing is happened again, over." The
12 victim told the suspect to stop.

14 The suspect put his penis in the victim's vagina. The suspect ejaculate a few minutes later
15 into his hand. The suspect said, "I'll kill you if you say anything." The victim left the room and
16 went to the bathroom to get dressed. The victim said the suspect had the cordless phone
17 with him and therefore, she could not call anyone.

19 The next morning the suspect and the victim drove to church together. The victim said she
20 did not tell anyone about the incident and acted as if she was happy. The victim said she did
21 not call her parents from church because she was afraid of the suspect. The victim said she
22 was also afraid of how her dad would react and said, "Scientology has so much control over
23 people. Especially over my dad."

25 The third incident occurred the next evening. The victim said that the suspect's fiancée
26 (**Susan Fieley**) had returned home from a business trip. The victim thought she would be
27 safe that night from the suspect because his fiancée was home. When the victim and the
28 suspect returned home from the church at approximately 2230 - 2300 hours, the three of
29 them watched television. At approximately 2330 hours, Witness Fieley went to bed.

31 After Witness Fieley went to bed, the suspect approached the victim as she was sitting on the
32 couch. He grabbed her upper arms and pushed her down. The victim said that this time was
33 more violent. The victim said she made a noise and said, "Stop." The suspect got angry and
34 put his hand around the victim's neck. [REDACTED]

I asked the victim if the suspect tried to choke her

35 The victim began to cry at this point and said, "Yea." I asked her if she could breath. The
36 victim said the suspect would squeeze her neck for a few seconds then let go. He repeated
37 this several times throughout the assault. The suspect said [REDACTED] *shut the fuck up bitch or I'll kill you.*
