1 The suspect ejaculated into his hand then got dressed. The suspect left the room and went to bed.

3 The victim said that the next incident occurred a week later. The victim said this incident occurred in the living room.  
4  
5 her. *the suspect choked the victim again while sexually assaulting her.*

7 The victim said that she believes the suspect sexually assaulted her approximately 100 times. Each time it occurred in the suspect's living room on the couch.

10 I asked the victim if the suspect ever did anything else to her. The victim said that in November or December of 2000, she was over at the suspect's house after they returned home from the church. She was sitting on the couch next to the suspect watching television. The suspect's fiancée was in the other room sleeping. The suspect approached the victim as she sat on the couch and grabbed her by her upper arms. The victim said the suspect "flipped" her over so her face was pressed into the couch and her knees were on the ground.

17 The victim was feeling nauseous and had difficulty telling me about what happened. I asked her if the suspect pulled her pants down and she said, "yes." I asked her what happened next. She said the suspect had his hand on the back of her head and was pushing her face into the cushions. As the suspect did this he pulled her pants down with his other hand. The victim said, *the victim said that at first the suspect was unsuccessful. She said, "He tried to, then I heard a spit. It sounded like he put it on his thing." The victim said he spit on his hand then put the saliva on his penis. The suspect then put his penis in the victim's anus*

*he was trying to stick his dick in my butt*

26 I asked the victim how long the suspect had his penis in her anus and she said, "Five minutes or so. It felt so long. It hurt." The victim said the suspect ejaculated inside of her anus. The victim said she noticed blood coming from the anus area when she went to the bathroom. While the suspect was sodomizing her she said, "It felt like I was going number two."

31 At this point in the interview the victim said she felt sick. I took her to the women's restroom where *she was*. The victim was perspiring, pale and clearly shaken. I asked the victim if she would like to conclude the interview at this time and she said yes. The victim agreed to come back next week to meet with me and finish the interview.
