Narrative:

On 6-24-02 at approximately 1545 hours I was working as the officer of the day for the Sexual Assault Unit. I was advised by Officer Sun, who was working at the Department's Information Center, that the victim walked in and reported that she had been sexually assaulted. I contacted Officer Sun and he briefed me on what the victim had told him in the initial interview. I then made contact with the victim and I walked her upstairs to the Sexual Assault Interview Room. I then took a formal interview from the victim. The following is a synopsis of my interview with the victim. The victim's interview was taped recorded with the victim's knowledge.

Statement:

I identified myself and gave the date and time for the record. I advised for the record how I became involved in this particular case. I advised that Officer Sun had briefed me on what the victim wanted to report. I had the victim identify herself for the record and give her date of birth and address. I asked the victim why did she come to the Police Station? The victim said she thought it would be good to file the report because she thinks what had happened to her should be reported. The victim said she had hid it at first. The victim started crying and said she did not want to be scared anymore.

I told the victim I talked to Officer Sun and he told him about a relationship with a particular church. I asked the victim what church she belonged to around August of 2000. The victim said ~~The Church Of Scientology in Mountain View.~~ The victim then described how the church functioned and when services where. The victim stated she attended services at the church.

I asked the victim if she worked at the church and she acknowledged working there. I asked the victim if the church paid her? The victim said yes. The victim said she was there for three years and gave the job description of each job she had at the church. ~~On her third year, the victim became a supervisor. The victim also stated that during that year is when everything happened. The victim was unable to tell me what happened and called it that sexual thing-molest.~~

I reviewed what the victim had told me. The victim told me her duties as a supervisor. ~~The victim said she was a supervisor.~~ The victim stated that the suspect had sexually did something to her. I asked the victim what was the suspect's position? The victim said that the suspect was a chief supervisor and was the highest trained in the world. The victim said that the suspect had trained in Florida and briefly told me the suspect's duties. I asked the victim what would the suspect be equivalent to? The victim said like a priest if I was trying to put it that way. I then had the victim tell me the suspect's ranking in the church. The victim stated approximately 2-3 levels down from the executive of the church. The victim gave the suspect's full name and a description.
