Statement Continued:

The victim reviewed the first incident when the suspect had pushed her in the bedroom. I asked the victim how she felt when the suspect had pushed in the bedroom? The victim said she did not like it all that it was strange. The victim said she thought the suspect was a trustworthy man. The suspect refused to let the victim call her father.

The victim went over what the suspect had told her in the living room. The victim said she did not want to be there at all.
