Statement Continued:

The victim said she was so scared to say anything after that. The victim started crying and said that she thought the suspect was going to kill her if she said anything at all. I asked the victim what happened after the suspect tried to tell her it was alright? The victim said she stayed on the couch and the suspect went into the bedroom. I asked the victim why she did not call her father and she advised me that the suspect had the phone.

The victim said the suspect did not touch her further that night and did not touch her anywhere else besides her vagina. The victim said the next morning they went to the church. The suspect advised the victim on the way to the church to remember what he had said. The victim said at the church she pretended like she was happy and acted like nothing was wrong. The victim said she did not tell anyone.

I asked the victim about how many times did this act happen? The victim said she was guessing because it happened to her a bunch of times. ~~The victim said she was guessing because it happened to her a bunch of times.~~ The victim said that every time it happened to her, it got worse. The victim said in the beginning it happened about every day, then it got less. The victim said that every time the act lasted about a minute. The last sexual assault occurred in May 2001. *The victim said about 700*

The victim described that the acts had stopped because she met her current boyfriend. The victim described how she met her boyfriend. The victim disclosed to her boyfriend what happened to her. After disclosing to her boyfriend about the sexual assault, the victim stopped going to the church. The victim said that the suspect told her that he was moving to Florida and that he wanted the victim to move with him. The victim said that now he was moving to Florida she could say something and he did not want that to happen. The victim said when he is at Florida, and if the victim said something, ~~he would come down and kill her and her family.~~ The suspect told the victim that nobody would know it was he because he is her best friend. I asked the victim if she thought the suspect has a lot of power in the church? The victim said when she was there the suspect had a lot a power in that particular church. *he would leave Florida & come down & kill her & her family.*

I asked why the victim came in today to make a report. The victim said she has a lawyer and the lawyer had given her legal advice to make a report. The victim said the lawyer is a civil lawyer and that a possible lawsuit will be filed against the church. My interview with the victim was concluded.

Action Taken:

I gave the victim a report receipt. Since there are possibly other victim's, further investigation is still needed. The Interview tape is retained at the Sexual Assault Unit.
