	<p>On 06-19-2003, I was assigned to Taraval Station (Street Crimes Unit) Along with Officers Lyons # 4067, Pak #1554 and Guarado #395. Officer Pak and I responded to 67 Riverton Drive regarding death threats. Upon our arrival we were met by (R/P Gorman) who told me the following: Today at approximately 1603 hours she answered the phone and was greeted by a man saying that (you and your whole family will be killed). Gorman stated that she and her family has received several other threats similar in nature( refer to SF case #030735722 and cad # 031700386). Gorman stated that she and her family members are in fear for their safety.</p>
